# The code of conduct and its scope

### 1. Ethics and Integrity

Suppliers must demonstrate compliance with this Supplier Code of Conduct upon request by Innovair Solutions.

Innovair Solutions reserves the right to impose the appropriate sanction for any misconduct based on its assessment of the seriousness of the supplier's breach.
